Supreme Court Visit New Delhi on 24 April 2019

The Faculty of Law, Bhagwant University, Ajmer in the academic year 2018-19, has organized a visit to the apex court of the country i.e. the Supreme Court of India. This visit was aimed at making the students aware of the functioning of the highest body of justice. The grandeur of the Supreme Court, along with a visit to the Supreme Court Museum took the students to the earliest days of the Court and its successful journey so far in its sacred task of dispensing justice.



The visit was permitted by the Supreme Court, New Delhi which was obtained by Ms. Deepika Sharma, HOD, Faculty of Law. Fifteen students from Faculty of law, Bhagwant University, Ajmer, visited the Hon'ble Supreme Court, New Delhi on 24th April, 2019. The students were accompanied by Associate Professor Dr. Sanjaya Choudhury, and Ms. Bharti Joshi, Assistant Professor. After a strict verification all participants have got their entry cards to enter into the Supreme Court premises. After that students enter into Bar Council of India premises and Advocate's chambers. Students visited the various court rooms i.e. 3, 6, 7, 8 and museum also. It provided a meaningful knowledge about judiciary system, judges and their status. Students visited the gallery of Chief justice i.e. our first judge Justice HJ Kania up to Deepak Mishra one by one.
